date of submission of application for Project Assistant.

2. **RELAXATION IN UPPER AGE LIMIT**

Govt. Employees who are working in the same line or allied cadre upper age limit will be relaxable by 5 years. Relaxation in the upper age limit of 5 years shall be admissible to all persons who had ordinarily been domiciled in Kashmir division of the state of Jammu & Kashmir during the period from 1^{st} January 1980 to 31^{st} day of December, 1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules.

Certificate regarding proof of residence – any person intending to avail of relaxation of age limit admissible shall submit a certificate from:

- (a) The District Magistrate in the Kashmir Division within the jurisdiction he had ordinarily resided; or
- (b) Any other authority designated in this behalf by the Government of Jammu & Kashmir to the effect that he had ordinarily been domiciled in the Kashmir division of the State of Jammu & Kashmir during the period from the 1st day of January, 1980 to 31st day of December 1989.

Relaxation in the upper age limit of 5 years shall be admissible to the children/ family members of those who died in the 1984 riots. Age relaxation to Ex-Servicemen will be as per Govt. orders.

NOTE: Only Date of Birth indicated in School Leaving Certificate or equivalent Certificate will be accepted. No subsequent request for change shall be granted.

3. **SELECTION PROCEDURE** Selection will be on the basis of performance in the Interview.

<u>NOTE</u>

(i) In case response is high, the Institute reserves the right to restrict the number of candidates to be called for interview to higher percentage of marks in the requisite qualification and or to conduct a screening test of the eligible candidates. The decision of the Institute in this regard will be final and binding.

(ii) SC/ST outstation candidates called for interview will be paid to & fro Travelling Allowance of 2nd class railway fare by the shortest route (subject to production of tickets) as per rules. However, Travelling Allowance is not admissible to those SC/ST candidates who are already in Central/State Government Services, Central/State Government Corporation, Public Undertakings, Local Government Institutions and Panchayat and the concession availed from Railways, if any, for undertaking journey for attending Interview.

(lii) Candidates may ensure that they fill in the correct information. Candidates who furnish false information will be disqualified for test/interview (as applicable).

4. COPIES OF CERTIFICATES TO BE SUBMITTED ALONG WITH APPLICATION:

Candidates should submit along with their applications, self-attested single copy of the certificates in support of:

- (a) Educational qualification, experience (as applicable) and technical qualifications (supported by appropriate mark sheets indicating the subjects offered at the examinations)
- (b) Proof of Date of Birth/Age

- (c) SC/ST candidates caste certificate should be issued by authorized authority in the prescribed format and the caste/community should have been included in the Presidential Orders in relation to the concerned State
- (d) Discharge from Defence Service (applicable to Ex-servicemen only)
- (e) Proof of the effect that they have been affected by 1984 riots (where applicable).
- (f) Certificate regarding domiciled in Kashmir Division from 1.1.1980 to 31.12.1989 (if claiming age relaxation for Kashmir division).

Nature of duty: The incumbent is expected to participate in the physics analysis using proton-proton collision data collected by CMS experiment at LHC. The candidate may also contribute to the R&D activities for the CMS detector upgrade. He / she should have interest in the scientific knowledge for introducing new techniques / methods in software / hardware, detector and its computer stimulation development for the experiments and present his / her results in the scientific communities such as conferences/ workshops in India and abroad.

Duration: **The position is purely temporary and coterminous with the project**. The position is initially for one year and likelihood of renewal for further period subject to continuity of the research grant of the Ramanujan Fellowship and satisfactory reviewing of the performance of the candidate.

WARNING: Applications which are not in conformity with the requirements will be rejected. The application which are not in the prescribed form or are not accompanied by the attested copies of Certificates, photograph will be rejected. Mere fulfilling of requirements as laid down in the advertisement does not qualify a candidate for test/ interview. No correspondence will be entertained with candidates not selected for test/ interview/appointment.
